## B. COMMUNITY DEVELOPMENT: MEYER

3. The township will help blow snow if the truck breaks down before we can get a new one.

4. Trustee Robards suggested that we go look at the City of New Baden's new truck and see if it is something like what we want.

5. Trustee Meyer thinks that we need to have a life expectancy on the vehicles and the equipment, so we won't be in this situation again.

6. Mayor Muniz also stated that the old police car is on its last leg and he was going to offer it to the fire department to use for practice.
