Chris McCulley, Chairman of Homecoming stated that we are letting the Lions try it since that's what they requested and the parade route we are just trying something new. She states this year we are giving the Homecoming a little bit of a face lift. Jim Lockeby also asked what we are planning to do with the Speed Limit on N. Douglas and Main St. He states people fly on these roads and wants to know if we are going to be known as a speed trap or a death trap? The police here are not doing anything about it.

Trustee Tolbert presents to the board the bid from Midwest Municipal Supply for the Radio Read Meter System for \$30,328.18 and believes we should go ahead and move forward with this. Discussion ensued on whether or not to purchase Radio Read Meter System. Trustee Ross made a motion to approve the Midwest Municipal Supply bid for the Radio Read Meter System for \$30,328.18. Trustee Gavlick seconds. Roll call vote, all in favor, motion passed.
