V. TREASURER REPORT

1. This report is for March, the end of fiscal year. Exhibit A has changes over prior month reports. Transfers into Debt Service and Debt Reserve Funds are reported as revenues since they are reported in the general fund as expenditures when they transferred out.

There is a deficit of \$162 thousand in the General Fund due to the purchase of a police car, the demolition of old Village hall (in March), transfers to the Debt Service and Debt Reserve accounts, and furnishings in new village hall. These things are unlikely to reoccur except for the transfers.

Motor Fuel Tax Fund has a deficit of \$130 thousand because of street repairs that were done.

There were several funds where the levy was not increased for this year. The Audit Fund has a surplus of \$12 thousand. The Social Security fund broke even. IMRF has a surplus of \$9 thousand. The Insurance Fund has a surplus of \$13 thousand.

The water and sewer funds are positive. That may change when Lindow runs out of properties because there will no longer be the volume of turn on and tap on fees.

The cash balance is \$802 thousand. Trustee Richeson made a motion to accept the treasurer report for March 2018. Trustee Ross second. Roll call vote, all in favor, motion passed.
