AN ORDINANCE AMENDING CHAPTER 38 OF THE REVISED CODE OF ORDINANCES REGARDING WATER AND SEWER RATES

WHEREAS, The Village Board of Trustees for St. Jacob, Illinois charges rates for water and sewer usage both within and outside of the Village of St. Jacob that are now increasing; and

WHEREAS, it has been the decision of the Board of Trustees to amend its water and sewer rates to pass the increasing rates on to the users of water and sewer services of St. Jacob; and

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE BOARD OF TRUSTEES OF THE VILLAGE OF ST. JACOB, STATE OF ILLINOIS, AS FOLLOWS:

SECTION 1: Section 38-4-11 and any amendments of the Revised Code of Ordinances of the Village of St. Jacob setting the water and sewer rates charged to users both inside and outside of the corporate limits of St. Jacob, Illinois are amended by deleting there from the original language and inserting in lieu thereof the following language:

<u>(E)</u>	BULK WATER SALES AT TANK	\$1.00 per 40 gallons			

SECTION 2: Any other ordinances or provisions of the Revised Code of Ordinances of the Village of St. Jacob that are inconsistent with Section 1 shall be and are amended to conform thereto. This ordinance shall become effective upon its passage, approval as required by law. The changes to rates will be assessed first during the June of 2023 billing cycle, and thereafter.
